**DRY LEASE OF SUITABLE AIRCRAFT FOR SRILANKAN AIRLINES LIMITED (SLA)**

Bids are invited by the Chairman of Bid Evaluation Committee on behalf of SLA, for the supply of suitable aircraft, from eligible and qualified bidders, on dry lease basis, for a period of 4 - 6 years or more as defined in the respective "BID ACKNOWLEDGEMENT FORM".

Bidding will be conducted through International Competitive Bidding (ICB) procedure. All interested eligible bidders who possess legal rights to dry lease potential aircraft, may contact SLA on or before 18<sup>th</sup> April 2022, through e-mail to **umega.seneviratne@srilankan.com** copying **rillhan.hussain@srilankan.com** and **sanjeewa.dissanayake@srilankan.com** with duly signed "BID ACKNOWLEDGEMENT FORM" which can be found at SLA's official website ([https://www.srilankan.com/en\\_uk/corporate/tender-notice](https://www.srilankan.com/en_uk/corporate/tender-notice)) together with "Supporting Documents" as defined below to confirm the legal rights for at least one aircraft which can be placed on dry lease with SLA for 4 - 6 years or more. The interested eligible bidders may bid for one or more suitable aircraft.

Following shall be submitted as "Supporting Documents":

- Profile of the bidder.
- Bill of sale or similar title confirmation document for the aircraft from the owner; or for future deliveries, the purchase order or an equivalent document.
- Authorization from the owner of the aircraft for the bidder to submit a bid to dry lease the aircraft and assurance that the owner agrees to enter into a lease agreement with SLA on the terms submitted by the bidder.
- Any information relating to existing financial arrangements/mortgage/liens on the aircraft (whether the aircraft is under a mortgage etc.)

Interested eligible bidders, upon submitting the duly completed "BID ACKNOWLEDGEMENT FORM" together with "Supporting Documents" shall receive the "Bidding Documents" from SLA.
